County Solid Waste Planning Process





Emmet's Early Steps

- Solid Waste Plan
- Hire dedicated staff
- Recycling Funding Committee
 - Short term funding: capital needs
 - Long term funding: operating/Enterprise Fund
- Consider options: Grants, millage, PA 185, PA 69, fee for service, ordinance, hauler licensing
- Hired consultant to facilitate process meetings of all stakeholders

Decision Making Process

- Initial Millage
- Recycle Funding Committee
- Solid Waste Ordinance
 - Pay-As-You-Throw
 - Flow Control for level playing field
 - License/Regulate Haulers



Start-up Funding

- Clean Michigan Fund grant
- Solid Waste Alternatives Program grant
- County millage (.25 mil, two year)

Seed funding critical!

 Many long term programs successfully operating today received grant funding from the state in the late 1980s early 1990s

Policy is key

- Best practices set policy that incentivizes and funds waste reduction and recycling
 - Solid waste flow control
 - Bundling of services
 - Franchising/competitive bidding
 - Embedded pricing
 - Pay as you throw
 - 'Free' comprehensive, convenient services
 - Landfill bans
 - Hauler licensing requirements



Solid Waste Ordinance

Licensing Haulers PAYT: Pay As You Throw Flow Control




Emmet County Solid Waste Ordinance

- Level Playing Field for Haulers
 - Solid waste haulers licensed by county
 - Haulers must use designated facility for disposal
 - Haulers must offer commercial cardboard collection



Flow Control Supreme Court Decision

- Flow Control "...is a convenient and effective way to finance... integrated package of waste-disposal services..."
- "create enhanced incentives for recycling..."
- "increase ability to enforce recycling laws..."














 - Tires, mattresses, some Construction & Demo materials
- Aggressive marketing of Recyclables
 - Funds processing
 - Drop sites
- Contracts for Services
 - Residential Curbside
 - Commercial Curbside



- equivalent to 270 roofs







Feeding Farms & Gardens, Not Landfills

- The 20-week pilot food scrap collection program included 20 restaurants and flower shops in Petoskey and Harbor Springs.
- We estimate that commercial food waste comprises 30% of the waste stream going to our local landfill
- Food scraps are resources from which restaurants can capture value by using reduction techniques, resources for feeding livestock, and, resources to compost to build the soil of local farms and gardens.



Highlights of program based on exit interviews

- Clean, convenient and comprehensive
- Even with small volumes, they saved on small things like trash liners
- Food scrap program is easier than recycling
- Twice a week service worked well-especially for flower shops because they receive deliveries two days a week
- "It's the right thing to do"
- Can see how their prep cooks are preparing food, to help correct bad habits
- We would take overflow
- Driver was friendly, courteous and helpful
- Education materials were helpful
- Helped identify further waste stream diversion opportunities
- Many people were already donating to food pantries or animals



Drop site bins as message centers



- Labeling of bins critical education opportunity (Teachable moment!)
 - No scavenging
 - Recycling info website address
 - Phone number
 - Visuals for what is (and is not) accepted
 - No littering
